USP-707 is ideally suited for the heavy-duty cleaning of tiled, porcelain stoneware, granite worktops and marble surfaces. May be used in industrial scrubber-driers, for mechanical parts, electric generator motors etc.

USP-707 is designed to clean and degrease all synthetic surfaces such as PVC, painted surfaces (decorator's preparatory cleaning solution), aluminium, zinc, brass, galvanized metal, stainless steel and plastic sheeting.

A heavy-duty cleaner that outperforms standard products, which is concentrated, odourless, with no need to rinse. Fast-acting, powerful degreasing properties, non-flammable, non-corrosive, non-caustic effect on building material.

Directions for Use / Application:

“Always test apply on a small hidden portion of the substrate before applying.”

This product is specially designed to degrease and clean all synthetic and stone surfaces.

Shake the container well before use

To apply:

Use: Sponge, cloth, hand sprayer, high-pressure equipment, scrubber-drier and then leave it to soak, allowing 5-30 minutes to act. When immersing items, allow to soak for 20 minutes, take out the parts, brush and rinse in running water

Guidelines for use:

Apply product to the surface using a sponge, moving from bottom to top, agitate with a firm bristle brush then wipe with a cloth or soft wipe. No rinsing required. The surface is ready to be treated or painted as soon as it has been wiped down.

To prevent future soiling, it is recommended to use a suitable protective treatment: **USP-100**.

Storage/Cleaning

Keep in a dry place (between 5°C and 30°C).

Storage: 24 months following the production date when kept in the original unopened container.

Immediately after you have finished, clean all tools and equipment with water.

Recommendations/Curing:

USP-707 contains no harmful, toxic or corrosive product. It is thus advised to wear gloves, safety goggles and an adequate combination during the period of use

To obtain the best look and results on application, **USP-707** should be shaken before use and must be used only when the temperature of the surfaces to be treated is > 5°C

Do not apply during rainy or very hot weather.

Respiratory Protection: Under normal conditions no special respiratory protection equipment is needed.

Hand Protection: Wear protective gloves

Skin Protection: Protective clothing
